Mae'r Gorchymyn hwn yn rhoi effaith i ddarpariaethau yn Rhan 3 o Fesur Plant a Theuluoedd (Cymru) 2010 ("y Mesur") mewn perthynas â thair ardal awdurdod lleol.

This Order brings into effect provisions in Part 3 of the Children and Families (Wales) Measure 2010 ("the Measure") in relation to three local authority areas.

Mae'r darpariaethau eisoes mewn grym mewn perthynas ag ardaloedd awdurdod lleol Bro Morgannwg, Caerdydd, Caerfyrddin, Casnewydd, Ceredigion, Merthyr Tudful, Powys, Rhondda Cynon Taf, Sir Benfro a Wrecsam. Mae'r Gorchymyn hwn yn dwyn y darpariaethau i rym mewn perthynas â thair ardal awdurdod lleol bellach, sef Castell-nedd Port Talbot, Pen-y-bont ar Ogwr ac Abertawe ar 1 Chwefror 2013.

The provisions are already in force in relation to the local authority areas of Cardiff, the Vale of Glamorgan, Carmarthen, Ceredigion, Merthyr Tydfil, Newport, Pembrokeshire, Rhondda Cynon Taff Powys and Wrexham. This Order brings the provisions into force in relation to three further local authority areas, namely Neath Port Talbot, Bridgend and Swansea on 1st February 2013.

Mae'r darpariaethau a ddygir i rym yn gosod dyletswydd ar awdurdodau lleol i sefydlu tîm integredig cymorth i deuluoedd ("tîm ICiD") yn eu hardal. Rhaid i fwrdd iechyd lleol y mae ei ardal yn cyfateb i ardal yr awdurdod lleol gymryd rhan wrth sefydlu'r tîm.

The provisions brought into force place a duty on local authorities to establish an integrated family support team ("IFS team") in their area. A local health board whose area corresponds to the local authority's area must participate in the establishment of the team.

Mae'r darpariaethau hefyd yn nodi'r mathau o achosion a all gael eu hatgyfeirio at dîm ICiD ac yn ei gwneud yn ofynnol i awdurdodau sefydlu bwrdd i

The provisions also set out the kinds of cases that can be referred to an IFS team and requires authorities to establish a board to oversee the team. Only

Title and Interpretation

1.—(1) The title of this Order is the Children and Families (Wales) Measure 2010 (Commencement No. 6) Order 2013.

(2) In this Order "local authority area" ("*ardal awdurdod lleol*") means that geographical area of Wales for which a local authority has responsibility.
