- (1) The Council may charge fees in connection with registration (including fees for restoration to, or retention in, the register).
- (2) The Welsh Ministers may, by regulation, make provision –
- (a) requiring employers of registered persons to –
 - (i) deduct (or arrange for the deduction) from the salary of a registered person any fee payable, and
 - (ii) remit that fee to the Council;
 - (b) about the arrangements to be adopted by employers in pursuance of paragraph (a);
 - (c) about the consequences of failing to pay fees (which may include refusal to register, or removal from the register).
- (3) The Council must prepare a scheme that makes provisions about the fees which may be charged.
- (4) The scheme may, amongst other things, make provision about –

- (a) the amount of the fees;
 - (b) exceptions and exemptions which may apply;
 - (c) administration charges which may be deducted by employers from any fees remitted to the Council.
- (5) In this section, “salary” includes any remuneration payable in respect of services provided by a registered person.
- (6) Welsh Ministers may issue guidance setting out the principles to be followed by the Council when determining the amount of fees to be charged.’.

- (6) No draft of an order under this section to give effect to the proposals ("the final draft order") may be laid before the Assembly in accordance with section 47(2)(e) until after the expiry of the period of 60 days beginning with the day on which the document relating to the proposals was laid before the National Assembly for Wales under subsection (5).
- (7) In calculating the period mentioned in subsection (6) no account shall be taken of any time during which the National Assembly for Wales is dissolved or is in recess for more than four days.
- (8) In preparing the final draft order the Welsh Ministers must consider any representations made during the period mentioned in subsection (6).
- (9) If the final draft order is laid before the National Assembly for Wales in accordance with section 47(2)(e), the order must be accompanied by a statement of the Welsh Ministers giving details of –
 - (a) any representations considered in accordance with subsection (8), and
 - (b) any changes made to the proposals contained in the document laid before the National Assembly for Wales under subsection (5) which are given effect to in the final draft order.'
